Ronald McDonald House (RMH) - The Utah RMH provided 23,479 overnight stays for pediatric patient families (11,096 individuals) in 2019. The average occupancy for the 72-room RMH was 91% for the year. The average length of stay was six nights. The RMH offered free lodging, five daily hospital shuttles, a fully stocked kitchen together with a magic room, princess and super hero parties, and hospitality programming for pediatric patient families traveling 35 miles or more to access specialty pediatric medical care for their children.

Ronald McDonald Family Room (RMFR)- RMFR welcomed 7,422 families (10,321 individuals) for 118,829 visits to our two RMFRs at Primary Children's Hospital in 2019. The eight overnight sleeping rooms within our RMFR averaged 95% occupancy and offered 2,773 overnight stays for parents of hospitalized children. The RMFR program offered respite for families of hospitalized children with overnight accommodations, daytime naps, showers, laundry, and a fully stocked kitchen.

Ronald McDonald Hospitality Carts (RMHC) - RMHCs within Shriners Hospital for Children and Ogden Regional Medical Center provided 2,482 pediatric patient families with free respite items.

The Organization's endowment funds consist of two funds established to support the social service mission of the Organization. The endowment consists of donor-restricted and board-designated endowment funds. The Organization has adopted an investment and spending policy for endowment assets that attempts to provide a predictable stream of funding to the programs supported by the endowments. The endowment assets are invested in a manner than is intended to produce returns that are 2% to 3% higher than the rate of inflation, while assuming a moderate level of investment risk. The Organization has a policy which allows all unrestricted and temporarily restricted portions of the endowment fund to be appropriated for expenditure at the discretion of the board of directors.

The Organization is exempt from federal income taxes under section 501(c) (3) of the Internal Revenue Code and therefore has made no provision for federal income taxes in the accompanying financial statements. In addition, the Organization has been determined by the Internal Revenue Service not to be a "private foundation" within the meaning of Section 509 (a) of the Internal Revenue Code.

The Organization's Forms 990, Return of Organization Exempt from Income Tax, for the years ending December 31, 2019, 2018, 2017, and 2016 are subject to examination by the IRS, generally for three years after they were filed. Generally accepted accounting principles require tax effects from an uncertain tax position to be recognized in the financial statements only if the position is more likely than not to be sustained if the position were to be challenged by a taxing authority. The assessment of the tax position is based solely on the technical merits of the position, without regard to the likelihood that the tax position may be challenged. If an uncertain tax position meets the more-likely-than-not threshold, the largest amount of tax benefit that is greater than 50% likely to be recognized upon ultimate settlement with the taxing authority is recorded. The Organization's primary tax positions relate to its status as a not-for-profit entity exempt from income taxes and classification of activities related to its exempt purpose. Management has evaluated the tax positions reflected in the Organization's tax filings and does not believe that any material uncertain tax positions exist.
